

Pursuant to Article 47, paragraph 7 of the Law on Electronic Document, Electronic Identification and Trust Services in Electronic Business (Official Gazette of the RS, No. 94/17),

The Minister of Trade, Tourism and Telecommunications has passed the following

RULEBOOK

on the Register of Qualified Devices for Creation of Electronic Signature and Electronic Seal

Subject matter

Article 1

This Rulebook shall prescribe the contents and the method of maintaining Register of Qualified Devices for Electronic Signature and Electronic Seal Creation (hereinafter: the Register), the method of filing applications for entry into the Register, required documentation to be enclosed with the application and the application form.

The Register shall be maintained by the Ministry in charge of information society (hereinafter: the Ministry).

Contents of the Register

Article 2

The Register shall include the following information:

- 1) the serial number of the entry in the Register;
- 2) the name of the electronic signature and/or seal creation device (hereinafter: the device);
- 3) applicant information:
 - (1) business name of the manufacturer,
 - (2) business name of the representative of manufacturer or of the importer of the device, where the application is submitted by the representative of manufacturer or by the importer of the device,
 - (3) the seat of the applicant (street and number, place, postal code and country);
- 4) the type of the device:
 - (1) the electronic signature creation device,
 - (2) the electronic seal creation device;
- 5) a note on the method of device use, where the device is envisaged to be used through the qualified electronic signature and/or seal creation device management service;

6) the name of the conformity assessment body for the qualified signature and/or seal creation device (hereinafter: the appointed body);

7) information on the certificate of conformity of the device and/or conformity assessment report for the device (hereinafter: the conformity assessment report), and specifically:

- (1) the issue date of the conformity assessment report for the device,
- (2) the report document on the conformity assessment of the device,
- (3) the number of conformity assessment reports,
- (4) the number of revocations of the conformity report,
- (5) the revocation date of the conformity assessment report;

8) another recognized conformity assessment method in compliance with Article 30.3 of the Regulation of the European Parliament and of the Council of the European Union No. 910/2014 of 23 July 2014 on electronic identification and trust services for electronic transactions in the internal market and repealing Directive 1999/93/EC (hereinafter: the eIDAS Regulation);

9) information on conformity report in compliance with the CC (Common Criteria), if any:

- (1) the number of conformity reports in compliance with the CC (Common Criteria), if any,
- (2) the name of the body that has issued the conformity report in compliance with the CC (Common Criteria),
- (3) the date of issue of the conformity report in compliance with the CC (Common Criteria), if any,
- (4) the conformity report document in compliance with the CC (Common Criteria);

10) the number of decision on entry in the Register;

11) the date of entry in the Register;

12) the basis for entry in the Register, which may be:

- (1) the conformity assessment of the device by the conformity assessment body for qualified electronic signature and/or seal creation devices (hereinafter: the appointed body),
- (2) retrieval from the list referred to in Article 31 of the eIDAS Regulation as a SSCD (Secure signature creation device),
- (3) retrieval from the list referred to in Article 31 of the eIDAS Regulation as a QSCD (Qualified electronic signature creation device),
- (4) on the basis of Article 46, paragraph 5 of the Law on Electronic Document, Electronic Identification and Trust Services in Electronic Business;

13) information on the entry of modifications in the Register and specifically:

- (1) the number of the decision on entry of modifications in the Register,
 - (2) the date of entry of modifications in the Register;
- 14) the information on deletion from the Register and specifically:
- (1) the number of the decision on deletion from the Register,
 - (2) the date of deletion from the Register.

All the modifications of information referred to in paragraph 1 of this Article shall be entered in the Register.

The qualified electronic signature and electronic seal creation device from the list which is, in accordance with Article 31 of the eIDAS Regulation, published by the European Commission, shall also be entered in the Register of Qualified Devices for Electronic Signature and Electronic Seal Creation.

Register maintenance method and publication method of information from the Register

Article 3

The Register shall be kept in hardcopy and in electronic form.

The Register in electronic form shall be publicly available on the website of the Ministry.

The Register in electronic form shall be signed by the advanced electronic seal of the Ministry.

Application method

Article 4

The application for entry in the Register (hereinafter: the application) shall be submitted electronically to the Ministry, in Form 1, which is printed with this Rulebook and is an integral part hereof, and which shall be published on the website of the Ministry.

The application referred to in paragraph 1 of this Article and the documentation that is to be enclosed with the application shall be delivered in the form of an electronic document in original or in the form of an authenticated digitalized act, in compliance with the Law on Electronic Document, Electronic Documentation and Trust Services in Electronic Business (hereinafter: the Law), to the electronic address of the Ministry.

The application can also be submitted in writing, either directly or by mail, in Form 1, and the documentation that is to be enclosed with the application shall be submitted in original form or alternatively a copy thereof authenticated by the competent authority shall be enclosed.

Required documentation to be enclosed with the application

Article 5

The applicant shall enclose the following with the application:

1) certificate of conformity, and/or report on conformity assessment of the device issued by the appointed body;

2) certificate of payment of administrative duty, in compliance with the law regulating Republic administrative duties.

Modification of information entered in the Register

Article 6

Application for modification of information entered in the Register shall be submitted, within eight days from the date of the change, in Form 2, which is printed with this Rulebook and is an integral part hereof and which shall be published on the website of the Ministry, in the manner referred to in Article 4 of this Rulebook.

Date of entry in the Register

Article 7

The Ministry shall enter the device in the Register on the date of passing of the decision on the entry in the Register.

Final provision

Article 8

This Rulebook shall enter into force on the eighth day from the date of its publication in the Official Gazette of the Republic of Serbia.
